### OCCUPATIONAL ASSESSMENT TAX FOR JULY 1, 2021-JUNE 30, 2022 FISCAL YEAR

The Brookville Area School District, Jefferson County, Pennsylvania, pursuant to the authority vested in the Board of School Directors by the laws of the Commonwealth of Pennsylvania, does hereby levy, assess and collect for general revenue purposes a uniform occupation tax of 2000 mills upon the occupational assessment of every resident or inhabitant of said School District.
